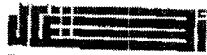

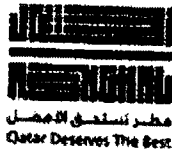

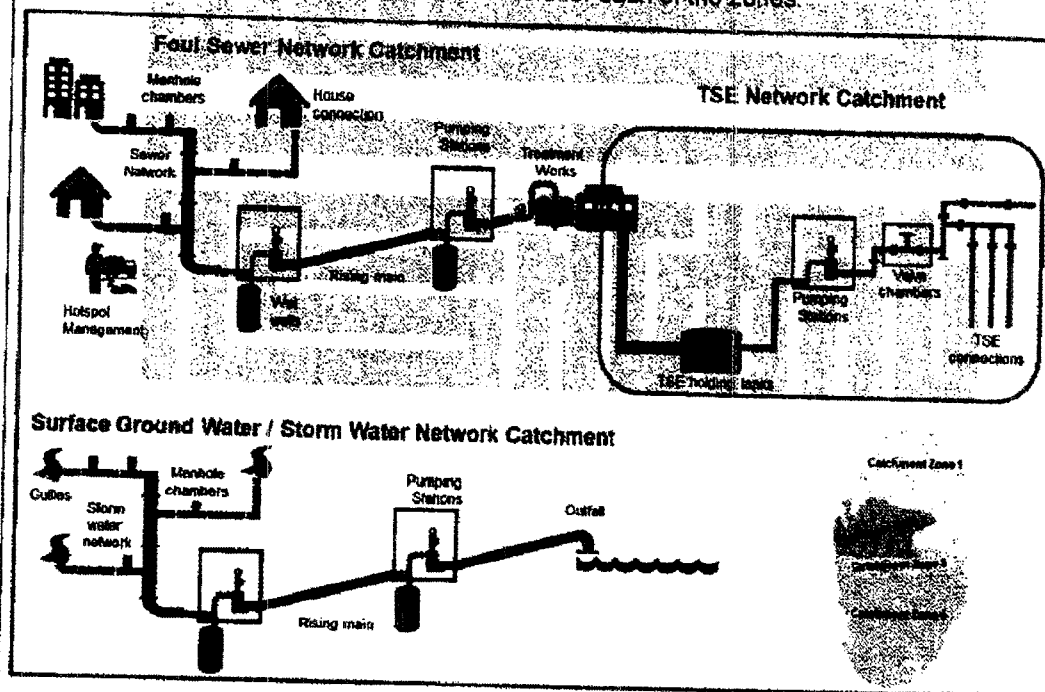
### 2019+ Procurement Strategy

### PROJECT OUTLINE

#### General

The Public Works Authority of Qatar wishes to procure Contractors to carry out operations & maintenance and repair, replacement and rehabilitation works under a Single Framework (FW) of 10-year duration.

Framework Contractors shall be awarded fixed Operation & Maintenance Works orders under specified Catchment Zones as well as initial planned repair, replacement and rehabilitation Work Orders for each of the zones.



Note: The Catchment Zones identified are for illustrative purpose only and are subject to change.

**Tendering for this Framework is planned to commence in Q1 2019**

#### Project Outline

The operation and maintenance scope of works includes:

- A. All existing authority operated pumping stations, Sewage Treatment Plants (STWs) and associated Foul, SGW and TSE networks within each zone;
- B. Any new pumping stations, STWs or network additions added to the Authority's assets during the framework contract period;

- C. Carrying out operations and maintenance activities on all equipment/system/unit installed on site including valve chambers, rising mains, valve chambers etc;
- D. The planned, preventive and reactive maintenance, overhauling and repair, refurbishment or enhancement of the site and associated systems;
- E. Disposal of waste products, bypass pumping and traffic management;
- F. The furnishing of all labour, supervision, vehicles, tools, materials, consumables, equipment, supplies, spare parts, emergency equipment, approved supplier workshop(s) and testing, incidental engineering, and transportation necessary for the completion of the works;
- G. The completing of records and reports throughout the term of each work order which shall be updated on the authority's computerized management system;
- H. Water quality testing at the STW and PS sites as required.

The repair, replacement & rehabilitation scope of works includes all civil, electrical and mechanical works related to:

- A. House connections;
- B. Gullies;
- C. Catch pits;
- D. Inspection chambers;
- E. Manholes;
- F. Four gravity sewers;
- G. Rising mains;
- H. Surface ground water pipelines;
- I. Treated sewage effluent pipelines;
- J. Lagbons;
- K. Soak-aways; and
- L. Any associated assets, fittings and accessories including all attenuation tanks, chambers, valves, covers, grates, signage and access.
- M. Any new assets added to the authority's network during the framework contract period.

#### Collaboration

Framework contractors will become key partners in the Authority's supply chain and shall be committed to working together in a collaborative manner to ensure the delivery of high quality, and cost effective solutions.
